

Please be aware that the process for renewing your Vehicle Licence requires that your application is submitted **no less than 14 days** before the licence is due to expire.

Application Process for a Hackney Carriage Licence

All applicants must provide the following information with their application:

	<p>On first application for a new Vehicle Licence, you must provide an Inspection and Test Certificate from a Council Approved Test Centre which is no more than 1 month old at the time of application.</p> <p>On Renewal Applications, You must provide an Inspection and Test Certificate from a Council Approved Test Centre that is no more than 1 month old at the time of application.</p> <p>You will need to make your own arrangements to have your vehicle inspected at an Approved Centre. The current Approved Test Centres are;</p> <p>Bridge End Garage, Macclesfield Road, Leek ST13 8LD – 01538 384250 SB Autos, Regent Street Leek ST13 6LP - 01538 528030 Cheadle Test Centre, Sarraine Ind. Park, Brookhouse Way, ST10 1SR - 01538 750737 Knypersley MOT Test Centre, Tunstall Road Ind. Estate, Knypersley ST8 7BD - 01782 522222</p> <p>You will need to obtain the Test Certificate direct from the Test Centre – they will no longer be sent to the Council.</p> <p>You will be required to submit a copy of the regular MOT for the vehicle at some point during the 12 month licenced period. This can be the regular due date of your MOT provided that it is at least 3 months after the new or renewal licence has been issued. If in doubt, contact the licensing service for further advice.</p> <p>When submitting an MOT, you must provide evidence that all ‘advisorys’ on the MOT have been attended to.</p>	
	You must provide a current Vehicle Registration Document	
	You must provide a valid Insurance Certificate or Cover Note	

	<p>For a New Vehicle Application, the vehicle must have no damage affecting the structural safety of the vehicle and must have no more than 75,000 miles on the odometer;</p> <p>For a Renewal Application, when the vehicle reaches a recorded mileage of 300,000 (as evidenced via the odometer/service records/maintenance history or other documentation) they will be deemed inappropriate to be licensed by the Authority as a Private Hire vehicle.</p>	
	<p>If you are not a licensed driver or operator with Staffordshire Moorlands District Council. You will need to make an application for a Basic Disclosure on-line at https://www.disclosurescotland.co.uk/</p> <p>The Disclosure must be no more than one month old at the time of your Vehicle Licence application.</p>
