ON HEARING the Solicitor for the Claimant, the 1st and 2nd Defendants not appearing;

IT IS ORDERED THAT

The 1st, 2nd and 3rd Defendants shall give the Claimant possession of the freehold land known as Victoria Business Park, Knypersley, Biddulph, Staffordshire and registered at HM Land Registry under Title Number SF430150 by midday on 26th January 2023.

AND UPON the claimant undertaking to:-

- erect notice of this injunction order at the entrances of the land and in at least 2 other prominent places viewable from Prospect Way, Victoria Business Park, Knypersley, Biddulph, Staffordshire, and,
- publish a copy of the Order on the Claimant's website and post information about the making of this Order on the Claimant's Twitter and Facebook pages, and
- make copies of the order available from the Council office reception at Moorlands House, Stockwell Street, Leek, Staffordshire during normal working hours,
within 3 clear working days of the making of this order;

IT IS ORDERED THAT the following injunction order be made:-

INJUNCTION ORDER:

- The 1st and 2nd Defendants shall not, without prior written consent from the Claimant, with or without vehicles, caravans or anything else remain, return to or enter upon the Land edged blue attached to this Order after midday on 26th January 2023;
- No person may park and stay in a caravan or vehicle or other structure or thing for the purpose of sleeping and/or habitation, whether permanent or not, within the area marked in blue on the plan attached without prior written consent from the Claimant after midday on 26th January 2023.

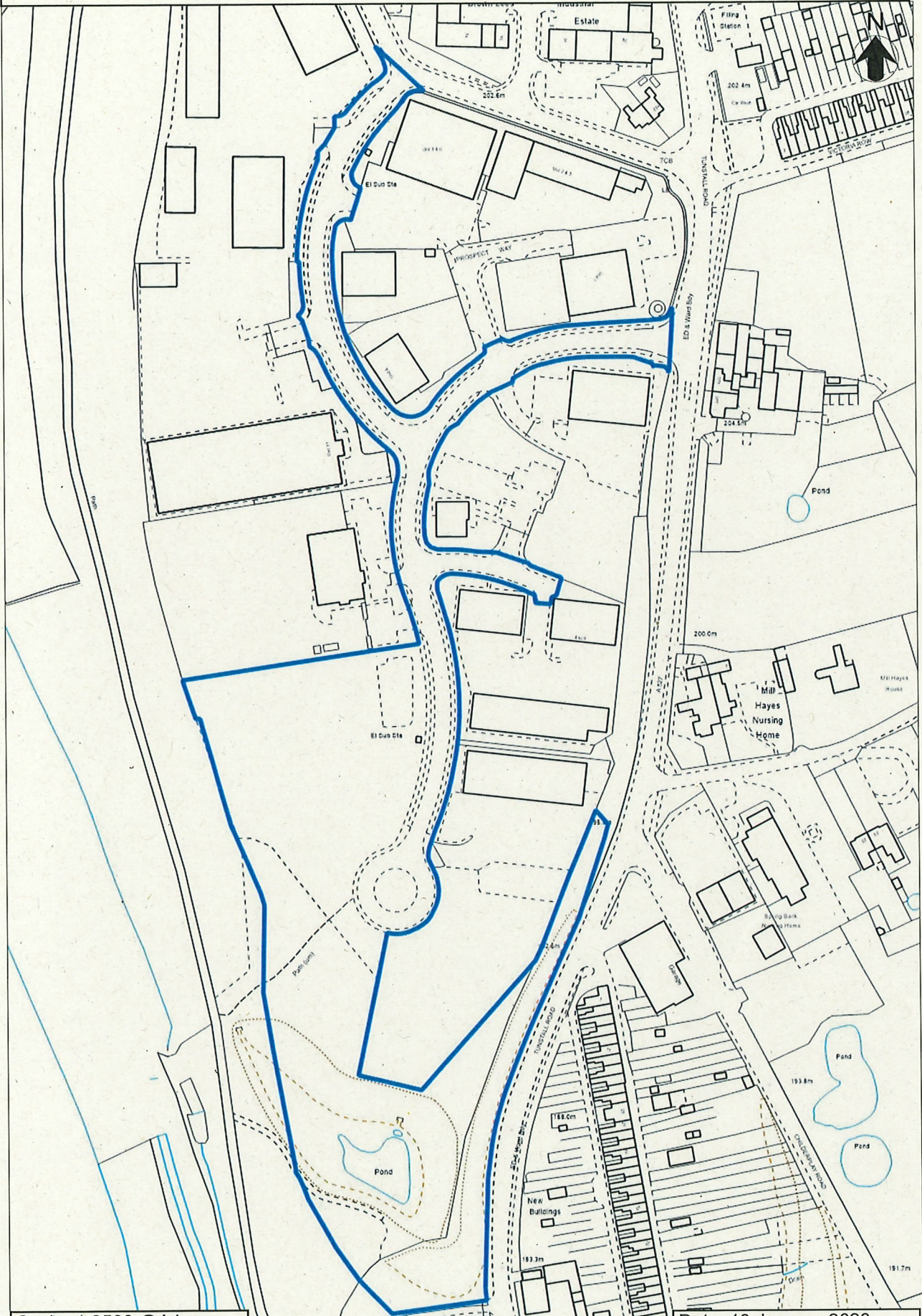
3) That the order shall expire at 4pm on the 25th January 2025 unless extended by prior application to the Court by the Claimant.
